ORDER TO FILE CONFORMING TARIFF

Effective Date: August 16, 2019

On August 15, 2019, the Commission held an on-the-record presentation regarding the Stipulations and Agreements that the signatories represented as resolving all contested issues in this rate case. During the presentation, Ameren Missouri requested that the Commission approve the stipulations and agreements, and allow new rates to go into effect on September 1, 2019.

The Commission has not made a decision concerning the stipulations and agreements. However, in consideration of Ameren Missouri's requested September 1, 2019, effective date for new rates, the Commission will order Ameren Missouri to file tariffs conforming to the terms of the stipulations and agreements. Thus, if the Commission approves the stipulations and agreements, conforming tariffs are also available for Commission approval to be effective on September 1, 2019.

The Commission's Staff shall review the tariffs for conformity to the stipulations and agreements. All other parties may file comments or recommendations concerning the tariffs.

THE COMMISSION ORDERS THAT:

1. Union Electric Company d/b/a Ameren Missouri shall file tariffs in compliance with the terms of the stipulations and agreements no later than August 16, 2019, at 5:00 p.m.
2. The Commission's Staff shall review any compliance tariffs and file a report regarding the compliance of Ameren Missouri's tariff sheets no later than August 19, 2019, at 5:00 p.m.
3. Any other comments or recommendations regarding the compliance of Ameren Missouri's tariff sheets are to be filed no later than August 19, 2019, at 5:00 p.m.
4. This order is effective when issued.
