ORDER GRANTING EXTENSION

On June 14, 2019,¹ the Commission ordered the Staff of the Missouri Public Service Commission (“Staff”) to file its recommendation on Missouri-American Water Company’s (“MAWC”) *Application and Motion for Waivers* no later than August 16. On August 14, the Staff filed a *Motion for Additional Time to October 11, 2019, to File Staff Recommendation*. On August 15, MAWC filed a response stating any extension should be limited to 30 days because a longer extension would push MAWC’s operational work on the system it proposes to acquire back into December when weather and personnel availability could present problems. The Commission will extend the deadline for Staff’s recommendation to September 15. The Commission may, however, grant Staff further extensions for good cause.

THE COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service Commission ("Staff") is granted a deadline extension for filing a recommendation on the *Application and Motion for Waivers*.
2. The Staff shall file a recommendation no later than September 15, 2019.
3. This order shall be effective when issued.
