## **EVERGY MISSOURI WEST'S NOTICE OF CORRECTED TESTIMONY**

With the rebasing of fuel for the FAC the revenue requirement is an increase of \$88.9 million. The initial request as filed by the Company on February 2, 2024 <u>including the rebasing of the FAC before the rebasing of</u> fuel for the FAC was an increase of \$104.5 million. The initial request with the rebasing of fuel was an increase of \$108.9 million."

- (iii) Schedule RAK-8: ln. 4
- (iv) Schedule RAK-9: lns. 2, 10, 15-16, and 19-20
