ORDER APPROVING COMPLIANCE TARIFF SHEET

Issue Date: September 16, 2024

Effective Date: September 29, 2024

On June 12, 2024,¹ the Commission issued its *Order Granting Certificate of Convenience and Necessity* (Order). The Order granted Union Electric Company d/b/a Ameren Missouri a certificate of convenience and necessity for a 150 megawatt solar generation facility to be constructed in Cass County, Illinois (the “Cass County Project”), subject to certain conditions.

On August 30, Ameren Missouri filed an original tariff sheet to publish the prices associated with auction results for the Cass County Project related to the Renewable Solutions Program. The tariff sheet purports to be in compliance with the Order, bears an effective date of September 29, and has been assigned Tracking No. JE-2025-0020.

At the Commission’s request, the Staff of the Commission (Staff) reviewed Ameren Missouri’s tariff sheet and, on September 9, filed its recommendation that the Commission approve the tariff sheet. No other responses were filed.

¹ Unless otherwise noted, all dates refer to the year 2024.

Based on Staff's recommendation, the Commission will approve the tariff sheet. To enable the tariff sheet to become effective on the date requested by Ameren Missouri, the Commission finds it reasonable to make this order effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheet filed on August 30, 2024, and assigned Tracking No. JE-2025-0020 is approved to become effective September 29, 2024. The approved tariff sheet is as follows:
