ORDER DIRECTING NOTICE, SETTING DEADLINE FOR INTERVENTION REQUESTS, AND DIRECTING FILING OF STAFF RECOMMENDATION

On August 21, 2019, Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") filed an application with the Missouri Public Service Commission ("Commission") seeking a waiver of certain meter testing requirements in anticipation of its deployment of Automated Metering Infrastructure beginning in 2020. The rule requested to be waived is 4 CSR 240 10.030(28), which outlines the requirements for periodic meter testing of utility meters, including electric utility meters.

While Ameren Missouri did not request expedited treatment, its Application noted the advantages of a decision before October 31. The Commission will direct its Staff to file a recommendation with regard to the application. The Commission will set a deadline for interested parties to intervene.

THE COMMISSION ORDERS THAT:

1. Any person wishing to intervene shall do so by filing an application to intervene no later than September 11, 2019. The application shall be filed in the Commission's Electronic Filing and Information System ("EFIS") or with the Secretary of the Commission.

- 2. No later than September 21, 2019, the Staff of the Missouri Public Service Commission shall file a recommendation or a request for additional time, regarding the application of Union Electric Company d/b/a Ameren Missouri.
 - 3. This order shall be effective when issued.
