ORDER STAYING PROCEEDINGS

The Commission created this docket to address the development and approval of a Cost Allocation Manual for Ameren Missouri, and address other matters respecting the Commission's Affiliate Transactions Rule. On August 8, 2019, the Commission issued an order amending the procedural schedule. An evidentiary hearing is set for October 29-30, 2019. On August 16, 2019, Ameren Missouri and the Commission's Staff filed a joint motion to stay the proceeding pending the outcome of the rulemaking in File No. AW-2018-0394, which the parties have indicated will affect this proceeding. On August 23, 2019, the Office of the Public Counsel filed a motion stating that it did not object to the stay.

The Commission finds that the motion to stay these proceedings is reasonable. That motion will be granted.

THE COMMISSION ORDERS THAT:

1. The joint motion to stay the proceeding is granted.
2. The evidentiary hearing set for October 29-30, 2019, is cancelled.
3. The parties shall file a motion to end the stay or a status report no later than November 4, 2019.

4. This order shall be effective when issued.


