On September 16, 2024,¹ Mr. Felber and Ms. Lambert filed a Motion for Extension of Time to File Subpoena Returns to extend the time to file by one week. Returns of service for the subpoenas were due by September 16.

Complainants explain that they have had difficulty receiving their mail and some of the subpoenas have not yet been served due to the service company being backlogged. Complainants will need additional time to serve the remaining subpoenas, receive the certificates of service and get them filed, requesting an extension to do so by September 23.

THE COMMISSION ORDERS THAT:

1. The Motion is granted. Any return of service of subpoenas or subpoenas *duces tecum* shall be filed no later than September 23, 2024.
