## ORDER SETTING TIME FOR RESPONSES

On August 30, 2024, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed tariff sheets, assigned Tracking Nos. JE-2025-0022 and JE-2025-0023, designed to comply with the Commission's Report and Order issued on May 15, 2024. The tariff sheets have an effective date of September 29, 2024.

On September 13, 2024, the Staff of the Commission filed a recommendation to approve the compliance tariffs or allow them to take effect by operation of law, and also to direct Evergy Missouri West to take reasonable steps to better align the application of solar participation generation with the billing of participants, for the reasons set out in Staff's recommendation.

Because the tariff sheets are set to become effective on September 29, 2024, the Commission will shorten the time for responses to Staff's recommendation.

**THE COMMISSION ORDERS THAT:**

1. Any responses to Staff's recommendation shall be filed no later than September 20, 2024.
2. This order shall be effective when issued.
