The Commission opened this file on December 16, 2020, as a working case to gather information about the possible amendment of the Commission's rule on reporting requirements for electric utilities and rural electric cooperatives. As part of the file, the Commission received comments from various stakeholders.

On July 31, 2024, in File No. EX-2025-0034, the Commission issued a *Finding of Necessity and Order Directing Proposed Amendment of 20 CSR 4240-3.190 Be Filed for Publication*. The proposed amendment was filed with the Secretary of State and was published in the *Missouri Register* on September 3, 2024.¹
