#### **STATUS UPDATE**

COMES NOW, Evergy Missouri West, Inc. d/b/a Evergy Missouri West ("Evergy Missouri West") (collectively, the "Company" or "Evergy"), by and through its counsel and, pursuant to the *Order Cancelling Evidentiary Hearings, Suspending Procedural Schedule, and Directing Filing of Status Reports* issued on May 9, 2024, and for its *Status Update* ("Status Update") states as follows:

- 1. <u>Lafayette County Case No. 23LF-CV00700</u>: Evergy filed a dismissal of the case on September 22, 2023. All claims related to the Circuit Court case have been fully resolved. Mr. and Mrs. Allegri filed a Motion to Dismiss on July 3, 2024. This was set for hearing on September 4, 2024 at 9:30 a.m. and a Notice of Voluntary Dismissal with Prejudice of Defendants' Pending Motions was filed by Mr. and Mrs. Allegri.
- 2. <u>Johnson County Case No. 23JO-CC00142</u>: Mr. and Mrs. Bracken filed a Notice of Hearing on July 29, 2024, stating their Motion for Reconsideration and Case Review and Motion for New Trial. Mr. and Mrs. Marsh also filed a Notice of Hearing on their Motion on August 16, 2024. A hearing was held on both motions September 13, 2024. The judge reiterated that the case

has been dismissed and that the court lacks jurisdiction to take any action. The judge declined to hear any of the motions and instructed the clerk not to schedule any more hearings in the case

3. There are no additional updates from the last Status Report submitted August 15, 2024.

**WHEREFORE**, the Company respectfully submits its Status Update for consideration by the Commission.
