Kansas City Power & Light Company (KCP&L) and KCP&L Greater Missouri Operations Company (GMO) filed a motion on August 23, 2019, asking the Commission to modify some of the terms of the stipulation and agreement regarding KCP&L and GMO's participation in the Southwest Power Pool, which the Commission approved in a June 19, 2013 order. Before ruling on the motion the Commission will give the other parties an opportunity to respond.

THE COMMISSION ORDERS THAT:

1. Any party wishing to respond to Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company's Motion to Modify Stipulations shall do so no later than September 3, 2019.

2. This order shall be effective when issued.
