On August 23, 2019,¹ the Commission issued its Notice to the Commission’s Staff of the witnesses whom the Commission wanted available to testify at the August 27-28, 2019, evidentiary hearing concerning the issue identified as Issue Two in the Parties’ List of Issues filed on August 9. The Commission’s Notice identified Matthew Young. On August 26, the Commission’s Staff filed a request to substitute Karen Lyons for Matthew Young, stating that Mr. Young would be unable to attend the hearing and be prepared to give testimony. The Commission will grant Staff’s request. The Commission states, however, that Mr. Young should also be available to testify by telephone if he is prepared and that is reasonably possible.

1. The request of the Staff of the Commission to substitute Karen Lyons for Matthew Young at the hearing of August 27-28, 2019 is sustained.
