## ORDER CANCELING CERTIFICATE AND TARIFFS

Issue Date: August 26, 2019 Effective Date: September 25, 2019

On August 2, 2019, in compliance with Commission Rule 4 CSR 240-28.011(3), Mitel Cloud Services, Inc. filed a letter asking to voluntarily surrender its certificate of service authority and to withdraw its tariff. Mitel explains that it serves its customers through VoIP and a variety of nomadic interconnected services as well as private business communication and collaborative solutions. As a result, the certificate granted by the Commission is no longer necessary.

The Commission's Staff responded to Mitel's letter on August 12 by filing a Motion to Cancel Certificate of Service Authority. Staff indicated the Commission granted Mitel certificate of service authority to provide competitive local exchange and intrastate interexchange services in File No. CA-2004-0485. Mitel has two applicable tariffs that should be canceled, YC-2015-0285 and YX-2015-0286

On August 13, the Commission issued an order allowing until August 23 to object or request a hearing. No objections or hearing requests were received.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Mitel's request and Staff's Motion to Cancel Certificate of Service Authority, the Commission finds that the certificate of service authority granted to Mitel, along with the company's accompanying tariffs, should be canceled.<sup>1</sup>

## THE COMMISSION ORDERS THAT:

- 1. The certificate of authority granted in Case No. CA-2004-0485 to Mitel Cloud Services, Inc. and Tariff Nos. YC-2015-0285 and YX-2015-0286 are canceled.
  - 2. This order shall become effective on September 25, 2019.
  - 3. This file may be closed on September 26, 2019.
