### ORDER DIRECTING FILING

On July 10, 2019,<sup>1</sup> the Commission Staff issued its Order Approving Transfer of Assets and Granting Certificate of Convenience and Necessity. The order authorized Franklin County Water Company, Inc. ("Franklin County") to sell and transfer utility assets to Liberty Utilities (Missouri Water) LLC ("Liberty Utilities") and transfer the CCN currently held by Franklin County to Liberty Utilities upon closing on any of the respective systems. The order required Liberty Utilities to submit tariff sheets prior to closing on Franklin County assets. Liberty Utilities filed Tariff Revision No. WY-2020-0036 on August 28. The filing states Liberty Utilities is closing on the asset transfer on September 30 and intends to begin providing service to the new customers on October 1. The proposed tariff sheets bear an issue date of August 27 and an effective date of September 26. The Commission will order the Commission's Staff to file a recommendation on the proposed tariff sheets.

#### The COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service Commission shall file a recommendation on Tariff No.: YW-2020-0036 no later than September 6, 2019.
