ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: August 28, 2019 Effective Date: September 27, 2019

On August 12, 2019, the Staff of the Missouri Public Service Commission filed a motion requesting Lattice Incorporated's ("Lattice") certificate of service authority and accompanying tariff to provide intrastate interexchange telecommunication service in the State of Missouri be cancelled.

In File Number XA-2013-0506, the Commission granted Lattice a certificate of service authority to provide intrastate interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that Lattice contacted Staff via letter stating Lattice was no longer providing service in Missouri and requesting the Commission cancel Lattice's certificate of service authority. Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange telecommunications services, and the company's accompanying tariff.

On August 13, 2019, the Commission issued an Order Establishing Time to Respond allowing parties until August 23, 2019, to file an objection or request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Lattice Incorporated, shall be canceled.

THE COMMISSION ORDERS THAT:

- 1. The certificate of authority to provide intrastate interexchange telecommunications services granted to Lattice Incorporated, in File Number XA-2013-0506, is canceled.
 - 2. Lattice Incorporated's tariff, P.S.C. Mo No. 1, is canceled.
 - 3. This order shall become effective on September 27, 2019.
 - 4. This case may be closed on September 28, 2019.
