On August 29, 2019, KCP&L Greater Missouri Operations Company (GMO) and the Staff of the Commission jointly filed a motion to modify the existing procedural schedule, including new dates for an evidentiary hearing. That procedural schedule, as modified by an order issued on August 26, would require the parties to file their rebuttal testimony on August 30. The proposed modified procedural schedule would require rebuttal testimony to be filed on September 9.

The August 29 motion was filed only by GMO and Staff, and does not represent that the other parties support the proposed schedule modifications. Because rebuttal testimony is otherwise due on August 30, the Commission will direct that any party wishing to be heard regarding the August 29 motion do so quickly so the Commission can issue an order informing all parties of whether rebuttal testimony should be filed on August 30.

THE COMMISSION ORDERS THAT:

1. Any party wishing to respond to the *Motion to Modify Procedural Schedule* filed by KCP&L Greater Missouri Operations Company and Staff shall do so no later than 9:00 a.m. on August 30, 2019.

2. This order shall be effective when issued.
