On July 10, 2019, ¹ the Missouri Public Service Commission ("Commission") issued its *Order Granting Certificate of Convenience and Necessity and Waiver*. The order approved a certificate of convenience and necessity for Missouri-American Water Company ("MAWC") to provide sewer service in the Hillers Creek service area after it acquires the sewer system assets owned and operated by Hillers Creek Association Sewer System. The order requires MAWC to submit new and revised tariff sheets that include a service area map, a service area written description, and sewer service rates for the Hillers Creek Service area, to become effective before closing on the assets.

On August 12, MAWC filed a Tariff Revision No. YS-2020-0026, and on August 26, MAWC filed a Substitute Tariff No. YS-2020-0026. This tariff sets out a sewer service area legal description and boundary area map. Its effective date is September 11. On August 28, MAWC filed a Tariff Revision No. YS-2020-0037. This tariff proposes a schedule of sewer service rates. Its effective date is September 27. The Commission will order the Commission Staff to file a recommendation on the tariffs.
