ORDER SCHEDULING LOCAL PUBLIC HEARING

On August 28, 2019, the Commission granted the request by the Lake Perry Lot Owners' Association and the Office of the Public Counsel to have a local public hearing. In that order, the Commission requested available hearing dates from parties. The parties submitted their dates, and the Commission will schedule the local public hearing based on the proposed suggestions.

The procedural schedule currently sets September 12 as the deadline for surrebuttal testimony, and will need to be delayed to account for the local public hearing. The Commission will reset the deadline for surrebuttal testimony.

THE COMMISSION ORDERS THAT:

- The Commission shall hold a local public hearing at the Colonnade Room,
 North Jackson Street, Perryville, Missouri 63775, on Tuesday, September 10, 2019,
 beginning at noon.
- 2. The local public hearing shall be held in a facility that meets the accessibility requirements of the American with Disabilities Act. Any person who needs an accommodation to participate in the hearing should call the Public Service Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711 before the hearing.

- 3. The Commission's Public Policy and Outreach Department shall make an informational presentation and conduct a question-and-answer session for the public at the beginning of the local public hearing.
- 4. The Commission's Public Policy and Outreach Department shall send a copy of this order to the members of the media and the General Assembly serving Perry County, Missouri.
- 5. Confluence Rivers Utility Operating Company, Inc., the Lake Perry Lot Owners' Association, the Commission's Staff, and the Office of the Public Counsel shall each prepare a one-page statement outlining their current assessment of the case, and shall bring sufficient copies for distribution at the question-and-answer session that begins the local public hearing.
- 6. Confluence Rivers Utility Operating Company, Inc., the Lake Perry Lot Owners' Association, the Commission's Staff, and the Office of the Public Counsel shall each make a representative available to address substantive issues during the question-and-answer sessions.
- 7. Any other party, at its discretion, may make a representative available to address substantive issues during the question and answer session.
- 8. The procedural schedule regarding surrebuttal testimony is from September 12 to September 17 as the deadline for surrebuttal testimony. Surrebuttal testimony may be used to respond to testimony or evidence offered at the local public hearing. The remainder of the procedural schedule remains unchanged.
