On May 30, 2024, Sprint Communications Company L.P. (Sprint Communications) filed a letter seeking to cancel Sprint Communications' registration to provide Interconnected Voice over Internet Protocol service ("IVoIP") in the State of Missouri. The Commission granted Sprint Communications its IVoIP registration in the State of Missouri in File No. DA-2012-0411.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹

Based on Sprint Communications' request, the Commission finds that the IVoIP registration granted to Sprint Communications shall be canceled.

IT IS ORDERED THAT:

- The registration to provide Interconnected Voice over Internet Protocol services, granted to Sprint Communications in File Number DA-2012-0411, is canceled.

 - 3. This case may be closed on September 28, 2024.
