The Missouri Public Service Commission is correcting its *Order Approving Stipulation and Agreement*, issued August 15, 2019, *nunc pro tunc* under 4 CSR 240-2.160(4) to accurately reflect that gen-tie facilities may be located in Holt County. Numbered paragraph two of the ordering paragraphs is hereby corrected to read: “Union Electric Company d/b/a Ameren Missouri is granted a certificate of convenience and necessity to construct and own a wind generation facility to be constructed in Atchison County, Missouri, which includes gen-tie facilities that may be located in Holt County, Missouri, under the Build Transfer Agreement with Enel Kansas, LLC, as described in its application, subject to the conditions set forth in the Stipulation and Agreement.”

1. The *Order Approving Stipulation and Agreement* issued August 15, 2019, is corrected *nunc pro tunc* as set forth in the body of this order.


