## ORDER DIRECTING STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On August 30, 2019, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheets in Tariff Tracking Number JG-2020-0040. According to the Company, the changes to the WNAR tariff sheets will reduce rates to the typical Liberty Utilities' residential customers in its Northwest and West Districts and will increase the average monthly bill of the typical residential customer in the its Southeast District. The tariff sheets bear an October 1, 2019 effective date.

The Commission will direct the Staff of the Commission to file a recommendation, and will establish a deadline for any other entity to file a response to the proposed tariff changes.

### THE COMMISSION ORDERS THAT:

1. No later than September 11, 2019, the Staff of the Commission shall file a recommendation regarding Tariff Tracking No. JG-2020-0040.
2. Any other entity wishing to respond to the tariff changes shall do so no later than September 11, 2019.

3. This order is effective when issued.

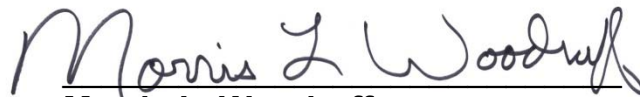
