**ORDER DENYING REQUEST TO RESCHEDULE  
LOCAL PUBLIC HEARING**

On August 29, 2019, the Commission issued an order scheduling a local public hearing based on the requests by the Lake Perry Lot Owners' Association (Lot Owners) and the Office of the Public Counsel. The local public hearing is scheduled for noon on September 10.

On September 3, Lot Owners requested that the local public hearing be rescheduled for 6:00 p.m. on September 10 to accommodate work schedules and travel time for individual lot owners wishing to testify. Lot Owners represent that Staff and the Office of the Public Counsel do not object to the change, and Confluence Rivers has indicated that while they disagree with the change, they will not object to the change in time if Staff and Public Counsel agree to it. Based upon the representations by Lot Owners' attorney, the Commission will issue its order now without waiting for replies to the Lot Owners' request.

The Commission gave the Lot Owners' request due consideration, as well as the number of individuals to be present at the hearing. After having considered the request, the Commission has determined that the hearing is appropriately scheduled.

**THE COMMISSION ORDERS THAT:**

1. The local public hearing at the Colonnade Room, 312 North Jackson Street, Perryville, Missouri 63775, on Tuesday, September 10, 2019, shall remain set at noon.
2. The *Lake Perry Lot Owners Association Request to Reschedule Local Public Hearing* is denied.
3. This order shall be effective when issued.

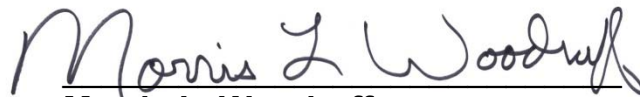
