## APPLICATION TO INTERVENE

COMES NOW Aquila, Inc. d/b/a Aquila Networks, Aquila Networks - MPS and Aquila Networks - L&P ("Aquila"), pursuant to Missouri Public Service Commission ("Commission")

Rule 4 CSR 240-2.075, and states as follows as its Application to Intervene:

- 1. Aquila is a Delaware corporation with its principal office and place of business at 20 West 9<sup>th</sup> Street, Kansas City, MO 64138. Aquila is authorized to conduct business in Missouri through its Aquila Networks-MPS and Aquila Networks-L&P operating divisions and, as such, is engaged in providing electrical, natural gas and heating company utility service in Missouri in those areas certificated to it by the Commission. A certified copy of Aquila's Amended Certificate of Authority to do business in this state as a foreign corporation was filed with the Commission in Case No. EU-2002-1053 and said documents are incorporated herein by reference in accordance with 4 CSR 240-2.060(1)(G). Likewise, copies of the registrations of fictitious name of Aquila Networks-MPS and Aquila Networks-L&P were filed in Case No. EU-2002-1053 and a copy of the registration of the fictitious name of Aquila Networks was filed in Case No. ER-2004-0072, and said documents are incorporated herein by reference in accordance with 4 CSR 240-2.060(1)(G).
- 2. Aquila is an "electrical corporation," a "gas corporation," a "heating company" and a "public utility" as those terms are defined in Section 386.020 RSMo 2000. Consequently,

it is subject to the jurisdiction and supervision of the Commission as provided by law.

3. Aquila has pending or final judgments or decisions against it from state or federal

regulatory agencies or courts which involve customer service occurring within the three (3) years

immediately proceeding the filing of this application. Aquila has no overdue Commission annual

reports or assessment fees.

5. On May 6, 2004, Kansas City Power & Light Company ("KCPL") filed a request

that the Commission open an investigation to discuss "constructive regulatory responses to

emerging issues that will affect the supply, delivery and pricing of the electric service provided

by KCPL." The Commission issued an Order Directing Notice and Setting Intervention Deadline

on May 25, 2004, wherein the Commission ordered that any interested party wishing to intervene

do so no later than June 1, 2004.

6. KCPL's application identifies several issues that are said to be "interrelated issues

of importance to KCP&L and its stakeholders." These issues are as follows:

- Capacity options;

- Emissions concerns;

- Price stability; and,
- Demand-side management programs and evaluation of new technologies for energy and account management.
- 7. Aquila is currently a co-owner of the Iatan Unit No. 1 power plant with KCPL and The Empire District Electric Company and is therefore interested in both the capacity and emissions subjects identified by KCPL. Aquila is also indirectly interested in both the price stability and demand-side subjects. Aquila seeks to intervene in this matter for the purpose of addressing all four of the subject described by KCPL. Aquila is unsure what position it may take as to the issues that may be raised in this matter.

WHEREFORE, Aquila prays that the Commission issue its order granting it permission to intervene in the above-entitled matter.
