ORDER DIRECTING STAFF TO FILE A RECOMMENDATION

On September 3, 2019, the Commission's Staff filed a motion to suspend tariff sheets filed by Spire Missouri on August 30, 2019. The Company's revised tariff sheet filings are intended to reflect the October adjustment made under the Company's WNAR for the six month period ending July 31, 2019. Staff asks the Commission to suspend the tariff sheets so that it has an opportunity to review the WNAR adjustment calculations.

The Commission will not suspend the tariff sheets at present as Staff's motion states its intent to complete a recommendation in sufficient time to allow the tariff sheets to take effect on the requested October 1, 2019, effective date.

The Commission will order Staff to file a recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a recommendation regarding Spire Missouri's tariff sheets no later than September 20, 2019.

2. This order shall be effective when issued.
