**ORDER DENYING APPLICATIONS FOR REHEARING**

On August 7, 2024, the Commission issued its *Report and Order* in this matter. That order became effective September 6, 2024. Complainants, Aquilla Canada and Dranel Clark, filed a timely application for rehearing on August 8, 2024, and filed an additional/supplemental request for rehearing on September 4, 2024.

Section 386.500.1, RSMo., states that the Commission shall grant an application for rehearing if “in its judgment sufficient reason therefor be made to appear.” In the judgment of the Commission, Ms. Canada and Mr. Clark’s applications for rehearing do not demonstrate sufficient reason to rehear this matter. Accordingly, the Commission will deny Ms. Canada and Mr. Clark’s requests for rehearing.

If the Complainants wish to appeal the Commission's decision, they must file a notice of appeal within thirty days of the effective date of this order in the appropriate appellate court in accordance with Section 386.510, RSMo.

**THE COMMISSION ORDERS THAT:**

1. Ms. Canada and Mr. Clark's applications for rehearing are denied.
2. This order shall be effective when issued.
