**ORDER SUSPENDING TARIFF**

On September 12, 2024, the Commission issued its order directing notice, setting an intervention deadline, directing a Staff recommendation, and consolidating cases. In that order the Commission stated that it would suspend the tariff sheets in a separate order so the Commission's Staff has adequate time to perform its review and the Commission has adequate time to consider the petition. Missouri-American Water Company's proposed tariff sheets bear an effective date of October 3, 2024.

The Commission will suspend the tariff sheets until March 2, 2025.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheets filed by Missouri-American Water Company on September 3, 2024, and assigned tariff tracking numbers JW-2025-0026 and JS-2025-0027, are suspended until March 2, 2025.

2. This order shall be effective when issued.
