ORDER ESTABLISHING TIME TO RESPOND

On September 19, 2024, Asset Black, LLC, by a letter signed by Robert Hagan, CFO and Executive Vice President of Momentum Telecom, Inc. , notified the Commission that the company no longer wished to be registered to provide Interconnected Voice over Internet Protocol (VoIP) service in the State of Missouri. The Commission granted Asset Black, LLC registration in File No. DA-2016-0158.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo (2016), which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Asset Black, LLC’s request is received, the Commission may cancel the registration based on Asset Black, LLC’s request.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing regarding the cancellation of Asset Black, LLC's IVolP registration.

THE COMMISSION ORDERS THAT:

1. Any party wishing to file an objection or request a hearing shall do so by filing a pleading no later than September 29, 2024, with:
