On August 27, 2024,¹ Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) and Missouri-American Water Company (MAWC) jointly filed an application requesting that the Commission approve the sale and purchase between them of nineteen small wastewater systems. The systems are in Callaway and Morgan Counties and total approximately 606 connections.

The Commission has issued notice of this application, and the Commission has received no requests to intervene. Thus, the Commission will order its Staff to file a Recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission’s Staff shall file a Recommendation, or a status report stating when it expects to file its Recommendation, no later than October 9, 2024.
