**ORDER DIRECTING FILING OF STATUS REPORT**

On December 17, 2018, the Staff of the Commission filed a recommendation and memorandum regarding its review of Spire Missouri, Inc. d/b/a Spire's 2016-2017 Actual Cost Adjustment for Spire's East and West service areas, in which Staff recommended an adjustment to reduce Spire's gas costs. Spire responded by stating that Spire and Staff agreed to meet in order to resolve the discrepancies that Staff noted. The parties met on April 10, 2019, and Staff has filed several status reports indicating that the parties continue to gather additional information in order to work out their disagreements. Staff stated in its status report filed on September 4, 2019, that it intends to file an additional status report on October 4, 2019.

The Commission will order its Staff to file an additional status report stating if additional time is needed for settlement discussions, or if a procedural conference is necessary to establish a procedural schedule.

**THE COMMISSION ORDERS THAT:**

1. The Staff of the Missouri Public Service Commission shall file a status report no later than October 4, 2019.
2. This order shall become effective when issued.
