NOTICE OF DEFICIENCY

On September 5, 2019, Fidelity Communication Services II, Inc. (Fidelity), filed a letter requesting that the Missouri Public Service Commission waive the North American Number Plan Pooling Administrator's decision to withhold certain numbering resources from Fidelity. Fidelity's application was not complete in that the letter filed is not a sufficient application pursuant to 20 CSR 4240-2.060. In addition, pursuant to 20 CSR 4240-2.080(1), pleadings filed with the Commission must be signed by at least one attorney of record authorized to practice law in Missouri. The letter is not signed by a Missouri attorney.

Fidelity may refile their corrected application in a new file. The Commission will not take action on this request at this time and this file will be closed.
