ORDER REGARDING MOTION TO SUSPEND PROCEDURAL SCHEDULE

On September 6, KCP&L Greater Missouri Operations Company (GMO), the Staff of the Commission, and Nucor Steel Sedalia, LLC filed a Non-Unanimous Motion to Suspend Procedural Schedule.¹ The motion asks the Commission to suspend the schedule until September 16, so that the movants can focus on settlement discussions. The motion asks the Commission to keep the case set for hearing on October 17 and 18. The motion further states that the Office of the Public Counsel does not object.

Midwest Energy Consumers Group (MECG) objected on September 6. MECG states that such a suspension would leave inadequate time for the parties to prepare for hearing.

The Commission finds the motion reasonable, and the Commission will grant the motion. Should any party believe it needs additional time to prepare for hearing, it may file a motion asking for the hearing to be continued.

THE COMMISSION ORDERS THAT:

1. The Motion to Modify Procedural Schedule is granted.
