## ORDER DIRECTING STAFF TO FILE RECOMMENDATION

On September 6, 2019,<sup>1</sup> KCP&L Greater Missouri Operations Company issued a Name Change Tariff No. JH-2020-0047<sup>2</sup> changing its name to Evergy Missouri West, Inc. d/b/a Evergy Missouri West. The effective date is October 7. The tariff sheets also state that Every Missouri West is adopting the tariffs of KCP&L Greater Missouri Operations Company.

On September 6, the Company also filed a Request for Variance or Waiver of Sixty-Day Notice, asking the Commission grant the Company a variance or waiver of Commission Rule 20 CSR 4240-4.017(1)

The Commission will direct the Commission Staff to file a recommendation.

### **THE COMMISSION ORDERS THAT:**

1. The Staff of the Missouri Public Service Commission shall file a recommendation regarding the Name Change Tariff No. JH-2020-0047 and Request for Variance or Waiver of Sixty-Day Notice no later than September 19, 2019.
