On September 11, 2019, Liberty Utilities (Midstates Natural Gas) Corp. filed substitute tariff sheets designed to correct a "methodology error" pointed out to it by Staff. - 2. The Office of the Public Counsel shall file its response to the tariffs in this matter no later than 10:00 a.m., September 13, 2019.
