ORDER ESTABLISHING TIME TO RESPOND TO MOTION TO COMPEL

On September 12, 2019, the parties participated in a telephone conference with the regulatory judge regarding a discovery dispute. After the telephone conference, intervenor Midwest Energy Consumers Group (MECG) filed a motion to compel KCP&L Greater Missouri Operations Company (GMO) to answer its data requests. The motion asks the Commission to order GMO to answer 11 data requests that MECG submitted to GMO. Because the hearing in this case is set to begin on October 17, 2019, MECG asks the Commission to expedite consideration of its motion. The Commission will direct GMO to respond to the MECG's motion in an expedited manner.

THE COMMISSION ORDERS THAT:

1. KCP&L Greater Missouri Operations Company shall respond to MECG Motion to Compel Responses to Data Requests from KCP&L Greater Missouri Operations no later than September 16, 2019, by 4:00 p.m.

2. This order shall be effective when issued.
