ORDER GRANTING VARIANCE

On August 28, 2019, Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") filed the above-referenced application. Ameren Missouri asks for a variance from its tariff sheet No. 29.1 and from Commission Rule 20 CSR 4240-2.090(2)(C).¹ Ameren Missouri requests the variance from the data request response times of that tariff sheet and rule due to personnel issues.

The Staff of the Commission filed its Recommendation on September 4, 2019. Staff does not object to the requested variance.

Commission Rule 20 CSR 4240-2.080(13) allows parties ten days to respond to pleadings unless otherwise ordered. The Commission issued no order to the contrary, more than ten days have elapsed since Staff filed its Recommendation, and no party objects to the variance request. Thus, the Commission will take up the request unopposed.

The Commission finds the application reasonable, and will grant it.

1. Union Electric Company d/b/a Ameren Missouri is granted a variance from Sheet No. 29.1, Rider A, Purchased Gas Adjustment Clause, Section 10(a) and from Commission Rule 20 CSR 4240-2.090(2)(C).
2. This order shall be effective September 26, 2019.
3. This file may be closed September 27, 2019.
