## ORDER APPROVING TARIFF

Issue Date: September 16, 2019

Effective Date: October 1, 2019

On July 10, 2019,<sup>1</sup> the Commission issued an *Order Approving Transfer of Assets and Granting Certificate of Convenience and Necessity* (“Order”). The order authorized Franklin County Water Company Inc. (“Franklin County Water”) to sell and transfer utility assets located in Franklin County, Missouri, to Liberty Utilities (Missouri Water) LLC (“Liberty Utilities”). It granted Liberty Utilities a Certificate of Convenience and Necessity to provide water service and required Liberty Utilities to submit tariff sheets prior to closing on the assets.

On August 27, Liberty Utilities filed Tariff Revision YW-2020-0036, and on September 3, Liberty Utilities filed a Substitute Tariff and Tariff Extension YW-2020-0036. The filing states closing on the assets is scheduled for September 30, customer service is to start October 1, and the tariff sheets are designed to comply with the Order. The tariff sheets’ effective date is October 1. On September 5, the Commission Staff filed its *Compliance Tariff Recommendation*. Staff reviewed the tariff sheets and concluded they

complied with the Commission's Order. Staff recommended approval. The Commission has received no other responses to the tariff filing or Staff's recommendation.

The Commission has reviewed the tariff filing and Staff's recommendation and determines the filing complies with the Commission's order.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheets in Tariff No. YW-2020-0036 issued on August 27, 2019, as substituted with Substitute Tariff and Tariff Extension issued on September 3, 2019, are approved, to become effective on October 1, 2019.
