**ORDER DIRECTING STAFF TO FILE A RECOMMENDATION AND
SETTING A TIME FOR RESPONSES**

The Commission directed its Staff (Staff) to file a pleading informing the Commission when Staff would be able to file a recommendation about Confluence Rivers’ request for a certificate of convenience and necessity (CCN). On September 13, 2024, Staff filed a pleading stating it could file a recommendation in this matter no later than November 1, 2024. The Commission will direct Staff to file a recommendation by that date and set a time for responses.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding Confluence Rivers’ CCN request no later than November 1, 2024.
2. Any responses to Staff’s recommendation or Confluence Rivers’ CCN request shall be filed no later than November 7, 2024.

3. This order is effective when issued.
