NOTICE THAT TARIFF SHEETS FILED IN COMPLIANCE WITH COMMISSION ORDER WILL BECOME EFFECTIVE

Issue Date: September 23, 2024

On August 30, 2024, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively "Evergy") filed tariff sheets, assigned Tracking Nos. JE-2025-0022 and JE-2025-0023, designed to comply with the Commission's Report and Order issued on May 15, 2024. The tariff sheets have an effective date of September 29, 2024.

On September 13, 2024, the Staff of the Commission filed a recommendation to approve the compliance tariffs or allow them to take effect by operation of law. The Commission set a time for responses to Staff's recommendation. No party responded, and no party opposed approval of the tariff sheets.

The Commission has reviewed the tariff sheets and Staff's Recommendation and Memorandum and finds that the tariff sheets should be approved. Based upon Staff's verified Recommendation and the tariff sheets, the Commission will take no action regarding the tariff sheets filed on August 30, 2024, assigned Tracking Nos. Tracking Nos. JE-2025-0022 and JE-2025-0023, and gives notice that those tariff sheets will go

into effect by operation of law on September 29, 2024.
