**ORDER CANCELING  
CERTIFICATE OF SERVICE AUTHORITY**

On September 9, 2024, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the certificate of interexchange telecommunications service authority and applicable tariff of Long Distance Consolidated Billing Co. (“the Company”). The Commission granted the Company a certificate to provide intrastate interexchange telecommunications service in File No. XA-2005-0159. The Company has a related tariff, P.S.C. MO. Tariff No. 1, under Tracking No. YX-2005-0434. Staff’s motion states that the Company wishes to voluntarily relinquish its authority and cancel any applicable tariffs.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo (2016), which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

The Commission issued notice and allowed time to request a hearing. There were no responses. The Commission need not hold a hearing if, after proper notice

and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, the Commission may cancel the certificate based on the Company's request.

Based on Staff's motion, the Commission finds that the certificate of service authority granted to Long Distance Consolidated Billing Co. shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The certificate of service authority issued to Long Distance Consolidated Billing Co. to provide interexchange telecommunications service in the state of Missouri is canceled.
2. Long Distance Consolidated Billing Co.'s tariff assigned Tracking No. YX-2005-0434 is canceled.
3. This order shall be effective October 24, 2024.
4. This file shall close October 25, 2024.
