#### ORDER EXTENDING DEADLINE

On September 13, 2019,<sup>1</sup> the Commission issued its *Order Granting Second Extension*, requiring the Commission Staff to file its recommendation on the *Application and Motion for Waivers* (the "Application") no later than September 18. On September 16, the Commission issued its *Order Directing Filing*, directing Missouri American Water Company (the "Company") and the Commission Staff no later than September 26 to file suggestions concerning the status of the Company's application, the identify of whoever is currently operating the water and sewer system in question, and by what authority it is operated. The Commission will extend the deadline for Staff's recommendation on the Application to match the date for filing suggestions on the status of the application.

#### THE COMMISSION ORDERS THAT:

1. The deadline for the Commission Staff's recommendation on the Application and Motion for Waivers is extended to no later than September 26, 2019.
