**JOINT MOTION FOR EXTENSION OF TIME TO FILE LIST OF ISSUES  
AND STATEMENTS OF POSITIONS**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”), by and through undersigned counsel, and on behalf of itself and the other parties (Union Electric Company d/b/a Ameren Missouri, Office of the Public Counsel, Missouri Industrial Energy Consumers, Inc., and Barnes-Jewish Hospital) to this proceeding files this Joint Motion For Extension Of Time To File List Of Issues And Statements Of Positions and the parties state as follows:

1. On October 13, 2011, the parties to this proceeding jointly proposed a procedural schedule that included, among other things, April 16, 2012 for the deadline for the filing of the List of Issues, List of Witnesses, Order of Cross-examination, and Order of Opening Statements (“List of Issues”) and April 17, 2012 for the deadline for the filing of Statements of Positions.
2. On October 28, 2012, the Commission issued an Order Adopting Proposed Procedural Schedule And Terms in which it adopted the jointly proposed procedural schedule.
3. The parties have been diligently engaged in this case, various of the parties having filed surrebuttal or cross-surrebuttal testimony on April 12, 2012, and other Commission proceedings.
4. The parties request an extension of time until Wednesday, April 18, 2012 for the filing of the List of Issues and until Thursday, April 19, 2012 for the Statement of Positions.

5. The evidentiary proceedings in this matter are scheduled for Thursday and Friday, May 3 and 4, 2012.

**WHEREFORE**, the Staff on behalf of itself and the other parties files this pleading requesting an extension of time until Wednesday, April 18, 2012 for the filing of the List of Issues, List of Witnesses, Order of Cross-examination, and Order of Opening Statements and until Thursday, April 19, 2012 for the Statement of Positions.
