UNOPPOSED MOTION TO AMEND PROCEDURAL SCHEDULE

COMES NOW Union Electric Company, d/b/a Ameren Missouri ("Company" or "Ameren Missouri"), and for its Unopposed Motion to Amend Procedural Schedule, states as follows:

- 1. On July 24, 2024, the Commission issued an Order Setting Procedural Schedule and Delegating Authority ("Order"). The Order set an evidentiary hearing from October 29, 2024 through November 1, 2024.
- 2. Recently, it came to the undersigned counsel for the Company's attention that two of the Company's witnesses will be called to testify in an evidentiary hearing in an unrelated, non-Commission case on October 29, 2024. This creates a conflict with the evidentiary hearings in this case.
- 3. Given the scope of the rebuttal testimony filed in this docket on September 13, 2024, the Company anticipates that it will take no more than three days to conclude the evidentiary hearings. Consequently, the Company consulted with the other parties, suggesting that the evidentiary hearings run from October 30, 2024 through November 1, 2024, which would resolve the witness conflicts. The Company also suggested that in the unlikely event more than three days were necessary to conclude the hearings, that an additional day of hearing on either November 4 or November 5, 2024, be reserved for hearing. Counsel for all of the other parties indicated they

did not oppose this change to the evidentiary hearing schedule, including reserving the additional day.²

WHEREFORE, Ameren Missouri respectfully requests that the Commission make and enter its order amending the Order and the procedural schedule reflected therein as outlined above.
