NOTICE OF DEFICIENCY

Issue Date: September 19, 2019

On September 18, 2019, Fidelity Communication Services I, Inc. and Fidelity Communication Services II, Inc. (Fidelity), filed an application requesting that the Missouri Public Service Commission waive the North American Number Plan Pooling Administrator's decision to withhold certain numbering resources from Fidelity. Fidelity's application was not complete in that pursuant to 20 CSR 4240-2.080(1)¹, pleadings filed with the Commission must be signed by at least one attorney of record authorized to practice law in Missouri. Further, Missouri law provides that a corporation may not represent itself in legal matters, but must act solely through licensed attorneys.² The application is not signed by a Missouri attorney.

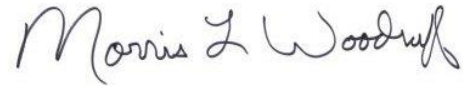
Fidelity may refile their corrected application in a new file. The Commission will

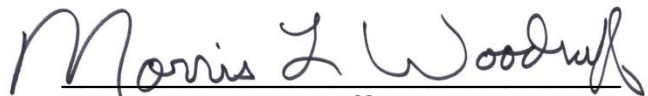
