ORDER DIRECTING FILING

Kansas City Power & Light Company (KCP&L) and KCP&L Greater Missouri Operations Company (GMO) filed a motion on August 23, 2019, asking the Commission to modify some of the terms of the stipulation and agreement regarding KCP&L and GMO's participation in the Southwest Power Pool, which the Commission approved in a June 19, 2013 order.

The motion explains that KCP&L, GMO, the Staff of the Commission, and Public Counsel have recently met to discuss the prudence of performing a cost/benefit analysis regarding KCP&L and GMO's continued participation in the Southwest Power Pool. As a result of those discussions, the parties agreed, given the substantial cost of performing such a study and the large exit fee obligations that would be incurred by KCP&L and GMO if they were to exit the Southwest Power Pool, the cost/benefit study should not be performed at this time. KCP&L and GMO would still be required to file their next application regarding participation in the Southwest Power Pool no later than June 30, 2020, but that application would not include the 2020 interim report regarding the cost/benefit analysis.

The Commission would like additional information about these matters before deciding whether to approve the motion to modify.

THE COMMISSION ORDERS THAT:

1. No later than September 25, 2019, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company shall file a copy of all analysis provided or performed by SPP that are referenced in Paragraph 4 of *Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company's Motion to Modify Stipulations*.

2. No later than September 25, 2019, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company shall file a summary of the work to be performed in the cost/benefit Preliminary Analysis Plan and a breakdown of the cost estimates for the proposed study.

3. This order shall be effective when issued.


