**ORDER RECOGNIZING NAME CHANGE  
AND APPROVING ADOPTION NOTICE TARIFF**

Issue Date: September 20, 2019

Effective Date: October 7, 2019

On September 6, 2019,<sup>1</sup> KCP&L Greater Missouri Operations Company (GMO) issued Adoption Notice Tariff No. JE-2020-0046 giving notice of a name change to Evergy Missouri West, Inc. d/b/a Evergy Missouri West. The effective date of the tariff is October 7. The tariff sheet also states Evergy Missouri West is adopting GMO's tariffs. On September 6, GMO filed a Request for Variance or Waiver of Sixty-Day Notice, asking the Commission to grant it a variance or waiver of the Rule 20 CSR 4240-4.017(1) 60-day notice requirement.

On September 19, the Commission Staff filed a recommendation stating Staff had reviewed revised Tariff Sheet No. JE-2020-0046 and the request for waiver. Staff recommends the tariff's approval, and states no objection to the waiver. The Commission will approve the adoption notice tariff and grant a waiver of the 60-day notice requirement for good cause shown.
