**ORDER SETTING TIME FOR RESPONSES TO STAFF'S  
RECOMMENDATION AND SPIRE MISSOURI'S WNAR TARIFF SHEETS**

On August 30, 2019, Spire filed tariff sheets to revise its Weather Normalization Adjustment Rider (WNAR). The company's revised tariff sheet filings are intended to reflect the October adjustment made under the company's WNAR for the six-month period ending July 31, 2019. The tariff sheets have an October 1, 2019, effective date.

The Commission ordered Staff to file a recommendation regarding the tariff sheets by September 20, 2019. On September 17, 2019, Spire Missouri filed substitute tariff sheets based upon Staff's suggested edits to the company's WNAR tariff sheets. Staff reviewed the WNAR adjustment calculations and filed a recommendation and report recommending Commission approval of the substitute tariff sheets.

The Commission will set a time for responses to Staff's recommendation and Spire Missouri's WNAR tariff sheets.

**THE COMMISSION ORDERS THAT:**

1. Any responses to Staff's recommendation and Spire Missouri's tariff sheets shall be filed no later than September 23, 2019, at 3:00 p.m.

2. This order shall be effective when issued.
