NOTICE ACKNOWLEDGING DISMISSAL

Issue Date: September 23, 2019

On March 20, 2019, George L. Eliceiri filed a complaint against Missouri-American Water Company. On September 19, 2019, Mr. Eliceiri, in a *Joint Request for Dismissal*, filed a voluntary dismissal of the complaint. The dismissal notes that the parties reached an agreement at mediation which resolves their dispute.

Commission Rule 20 CSR 4240-2.116(1)¹ states that a complainant may dismiss a complaint without an order of the Commission before prepared testimony or oral evidence has been offered. The parties have not offered prepared testimony or oral


