On August 29, 2019, Confluence Rivers Utility Operating Company, Inc. filed a notice opening a staff assisted rate case under Commission Rule 20 CSR 4240-10.075. Subsection 6 of this rule requires a local public hearing to be scheduled to occur no later than 60 days after the opening of the case. In this case, the 60 days expires on October 28, 2019.

The Commission will direct the parties to file a response offering recommended locations and dates for local public hearings.

**THE COMMISSION ORDERS THAT:**

1. No later than September 25, 2019, the parties in this case shall file a response detailing their recommendations regarding local public hearings in this case.
2. This order shall be effective when issued.


