**ORDER GRANTING MOTION TO SUSPEND FILING
OF STAFF RECOMMENDATION**

On April 18, 2024,¹ Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application regarding the acquisition of the unregulated sewer assets of Barbara E. Rampone located in and around the Timber Ridge subdivision in Johnson County, MO (Timber Ridge). The Commission directed a recommendation from its Staff (Staff) due no later than June 11, extended to July 25, and subsequently extended to September 23.

On September 23, Staff filed its Motion to Suspend Filing of Staff Recommendation (Motion). Staff explained that Confluence Rivers plans to amend its application at an uncertain future date, thus Staff has requested the Commission to suspend the requirement for Staff to file a recommendation until such time as Confluence Rivers files its amended application. Staff's Motion indicates it discussed this request with counsel for Confluence Rivers and counsel had no objection.

The Commission finds the request reasonable and will grant the suspension. Upon the filing of the amended application by Confluence Rivers, the Commission will re-order the filing of a Staff recommendation.

1. The Motion to Suspend Filing of Staff Recommendation is granted.
2. This order shall be effective when issued.
