### ORDER GRANTING MOTION FOR EXTENSION OF TIME

On August 21, 2019, Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") filed an application with the Missouri Public Service Commission ("Commission") seeking a waiver of certain meter testing requirements in anticipation of its deployment of Automated Metering Infrastructure beginning in 2020.

Thereafter, the Commission ordered the Staff of the Commission ("Staff") to file a recommendation or a request for additional time no later than September 21. In a motion filed on September 20, Staff requests an extension of time to October 8, for the completion of discovery, which Ameren Missouri indicated would be expedited, as Ameren Missouri had previously noted in its Application the advantages of a decision before October 31.

The Commission finds that the request for extension is reasonable and will grant it.

## THE COMMISSION ORDERS THAT:

- 1. The request for an extension of time filed by Staff on September 20, 2019, is granted.
  - 2. Staff shall file its recommendation no later than October 8, 2019.
  - 3. This order shall be effective when issued.
